heirs and assigns forever. And it does hereby bind itself its successors and assigns, to warrant and forever defend all and singular the said Premises unto the said Mary G. Traxler, her heirs and assigns, from and against itself and its Successors and Assigns and every person whomsoever lawfully claiming or to claim the same or any part thereof.
