per centum to be computed and paid, until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including 10 per cent. of the indebtedness, as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

lease unto the said George Norwood, his heirs and assigns:

All that Piece, Parcel or lot of land in Oakland Township, Greenville County, State of South Carolina, and having the following Bmites and bounds: Beginning at a stone on Selene Avenue on a line between lots nos. 15 and 16, and running thence with said line S. $65^{\frac{3}{4}}$ E. 5.22 chains to a stone; thence N. $20^{\frac{3}{4}}$ E. 3.60 chains to a stone; thence N. $65^{\frac{3}{4}}$ W. 5.22 chains to a stone on Selene Avenue; thence with Selene Avenue S. $20^{\frac{3}{4}}$ W. 3.60 chains to the beginning corner, containing one and 88/100 acres, more or less, and known as Lot no. 15 on Plat of Arden, made by Jno. McBurton, D.S., Nov. 10th, 1906.

Being the same lot of land conveyed to Ottaway Investment Corporation by Blythe Nabors, October 29th, 1926. This mortgage is junior to one certain mortgage in the sum of \$161.50
