Paid May 9th 1922 and paid in full; all interest not paid when due to become due at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of 10 per cent.

Dahson, my right, title, and interest in and to a certain lot of land situated in the town of Greenville, Greenville County, State of South Carolina, bounded on the south side of National Highway No. 8 between Taylors and Greenville, adjoining lands of Mannie Easter, T. W. Dill, and having the following metes and bounds: Beginning on National Highway on T. W.
