bargain, sell and release unto the said *G. F. Fowler* All that piece parcel or tract
of land situate lying and being in Grove Township
County and State aforesaid, and containing nine and
one fourth acres more or less and being the same
land conveyed to me by W. J. Rhodes by deed date Jan
8th 1919 and recorded in Vol 50 page 236 in Office of R. M. C.
for said County and State aforesaid,

Also all that other piece parcel or tract of land situate
lying and being Township County and State aforesaid
and joining the above described tract and being
conveyed to me by W. J. Rhodes in same deed mentioned
above, also all that other piece parcel or tract of land
