bargain, sell and release unto the said The Peoples National Bank of Greenville:

All that piece, parcel or lot of land beginning at an iron pin
on Whitsett Street at the joint corner of the property formerly
owned by W. N. Cruikshank and running in a southerly
direction one hundred and twenty-six (126) feet one inch
(1) to a pin on a ten (10) foot alley, thence in an easterly
direction with said alley fifty-five (55) feet and two (2) inches
to a pin, thence in a northerly direction one hundred
and twenty-six (126) feet and one (1) inch to a pin on
Whitsett Street, thence in a westerly direction with
Whitsett Street fifty-five (55) feet and two (2) inches to
the beginning corner, and being lot number one as
shown by a survey of Harold B. Deal, May 28th, 1910.
Being the same lot of land conveyed to me by J. S. Westcott.
