SEND GREETING:

WHEREAS, I, the said Sallie A. Green

Dollars, to be paid on October 15, 1926

with interest thereon, from maturity at the rate of 8% per cent. per annum, to be
computed and paid semi-annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid; then the whole amount evidenced by said note, to become immediately due at the option of the holder hereof, who
may sue thereon and foreclose this mortgage; said note further providing that in the event of default by the mortgagor, the holder hereof, who
besides all costs and expenses of collection to be
added to the amount due on said note, to be collectible as a part thereof, in the same place in the hands of an attorney for collection, or if said debt, or any
part thereof, be collected by an attorney or by legal proceedings, all of which is secured under this mortgage; as in and by the said note, reference
being thereunto had, as will more fully appear.)

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant,
bargain, sell and release unto the said The Woodside National Bank

All that certain piece, parcel or tract of land, situated,
lying and being in the State of South Carolina and County
of Greenville and described by metes and bounds as follows,
to wit:

Beginning at a beech (beech) 3x0m on Reedy Fork Creek, and
running thence South 68 1/4 West forty seven and 30/100 chains
to a R. Oak (gone) now a stone 0m; thence S. 27 1/2
West Forty six and 100/100 chains to a stone 0m (old painter)
thence South 62 1/2 East Fifty-four and 50/100 chains to stone
3x0m; thence North 7 West Twenty seven and 74/100
chains to a stone 3x0m; thence North 45 1/4 East Twenty
four and 40/100 chains to a beech 3x0m, on Reedy Fork
Creek; thence along the meander of said creek to the
beginning corner containing three hundred and sixteen
acres, more or less, and designated as tract "A" on
