until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who
may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of Fifteen (\$15.00) Dollars

besides all costs and expenses of collection to be
added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any
part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage; as in and by the said note, reference
being thereunto had, as will more fully appear.)

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant,
bargain, sell and release unto the said Prof. J. E. Martin, all that certain parcel

or lot of land in County of Greenville, State of South Carolina, and in the Sixth Ward of the City of Greenville, on Green Avenue, containing slightly more than one eighth of an acre, be the same more or less, having a frontage of sixty (60) feet on said Green Avenue and a depth of about one hundred and seven (107) feet; bounded by lands formerly belonging to J. B. Davis, Anderson Jones, B. W. Farrow and by said Green Avenue; being next to the corner lot owned by B. W. Farrow, and being a part of the lot of land conveyed to B. W. Farrow by Anderson Jones by deed dated June 13, 1894 and recorded in Book 666, page 403, R. M. C. office for Greenville County and the same lot of land conveyed to me by the said B. W. Farrow by his deed dated Jan 11, 1901 and recorded in Vol. III, page 753, R. M. C. office for Greenville County. This lot is now fenced in and the fence is intended to be the boundary line on all sides and four iron pin marks each of the four corners.

There is no other lien or encumbrance on said land by mortgage, judgment or otherwise, except a first mortgage given by me to L. O. Patterson, as Trustee for R. H. & W. P. White for \$650.00 dated July 19, 1921 and recorded in said R. M. C. office. This is a second mortgage.
