WHEREAS, *I*, the said *B. O. James*  
in and by *me* certain note or obligation, bearing date the *14th* day of *May* 192*6*

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate,  
duly incorporated under the laws of such State), in the sum of *Five hundred \$500.00* Dollars,  
with interest thereon at the rate of eight per centum per annum, payable monthly, from the *14th* day of *May* A. D. 192*6*,
