That I, Effie B. Sloman, of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

Lot 11 and 12 (1) of the City of Greenville, on Hampton Avenue, beginning at an iron pin on said Hampton Avenue, 109.2 feet from Whitner Street and running thence N. 28-20 E. 149.5 feet to an iron pin; thence S. 62-45 E. 106.8 feet to iron pin on Whitner Street; thence with Whitner Street S. 28-50 W. 13 feet to iron pin corner of lot of Effie B.
