

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

That I, Belle Hardin Gantt of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting;

WHEREAS, I, Belle Hardin Gantt, the said, in and by J. W. Gantt certain note or obligation, bearing date the 14th day of July 1926

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Fifty Five Hundred & No/100 (\$5500.00) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 14th day of July A. D. 1926,

according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that I, the said Belle Hardin Gantt shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of July 1926, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of \$58.33

Dollars, (\$35.00) Dollars, being the regular monthly installment payable on the thirty (30) Shares of Stock, and \$23.33

Dollars, being the monthly interest on (advance on loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of \$5.33

Dollars, being the regular monthly payment of said stock and \$16.67 Dollars, being the monthly interest on balance due); for the next twenty months the sum of \$44.00

Dollars, being the regular monthly payment on said stock and \$14.00 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of \$44.33

Dollars, being the monthly payment on said shares of stock and \$35.00 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of \$39.67

Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of \$35.00 Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said 35 shares of stock and the certificate thereof, the amount at such time said shares by me to be credited as a payment upon the advance or loan made, the said Belle Hardin Gantt

and shall pay or cause to be paid all fines which may be lawfully imposed upon, or charged against I, the said Belle Hardin Gantt

in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, Belle Hardin Gantt, the said, in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me

the said Belle Hardin Gantt in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

Beginning at an iron pin corner of lot sold by Blythe and Arnold to Miller, Agent, on East North Street, thence with Miller's line S. 15 E. 126 feet and 1 inch to an iron on a ten foot alley, thence S. 76 E. 45 W. 49 feet to iron pin corner lot now or formerly owned by E. M. Blythe, thence with said lot N. 15 W. 126 feet and 1 inch to iron pin on North Street thence with North Street N. 76 E. 49 feet to the beginning corner, being the same lot conveyed to J. W. Gantt by E. M. Blythe, by deed recorded in Deed book 78, page 256 and by J. W. Gantt to Belle Hardin Gantt, by deed dated February 6th, 1923, and recorded in deed book 78 page 482 R. M. C. Office for Greenville County.
