WITNESSETH, Whereas, the said party of the first part is indebted to said MECHANICS BUILDING AND LOAN ASSOCIATION in the sum of

Twelve hundred (\$200.00)

Dollars, money loaned this day, with interest thereon from this date at the rate of eight per cent. per annum, payable weekly,

the payment whereof the said party of the first part is anxious to secure:

Now, therefore, in consideration of the premises, and in further consideration of one dollar to him in hand paid, the receipt whereof is hereby acknowledged, the said party of the first part has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the said party of the second part all that certain piece, parcel or lot of land lying in Greenville County, in the State aforesaid, as follows, to-wit:

All that certain piece, parcel or lot of land containing 28/100 Acres more or less and situate in the County of Greenville, State aforesaid. And in the ~~outhward~~ of the City of Greenville and has the following ~~limits~~ and ~~bounds~~.

Beginning at an iron pipe ~~at~~ southwest corner Kleinie and Lower streets ~~at~~ the ~~cross~~ of Kleinie street N. 60 1/2 W. 124 feet to iron copper ~~iron~~ pipe ~~at~~ Lower street, thence with Kleinie street S. 19 1/2 E. 60 1/2 feet to iron pipe on old Ware line thence S. 19 1/2 E. 60 1/2 feet to iron 3x, thence N. 57 E. 15 2/3 feet to the beginning corner.
