I, R. Mays Cleveland, of Greenville County in the State aforesaid,

SEND GREETING:

WHEREAS, I, the said R. Mays Cleveland  
in and by my certain instrument, note in writing, of  
even date with these presents, \$2,000.00  
in the full and just sum of Two Thousand (\$2,000.00)  
Dollars, to be paid one year after date,

with interest thereon, from late at the rate of 5 per cent. per annum, to be computed and paid annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten per cent

besides all costs and expenses of collection to be added to the amount due on said note to be collectible on a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal procedures of any kind (all of which is secured under this mortgage; as in and by the said note, reference being thereunto had, as will more fully appear.)

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said J. Norwood Cleveland, his heirs and assigns

forever, all my undivided one-half interest in and to all that tract of land situate in the State and County aforesaid in the Town of Marietta, containing 136 acres, more or less, and being known and designated as Cleveland Heights and Cabin-on-the-Hill Place and having a frontage of approximately one-fourth of a mile on Cleveland Avenue and being bounded on the north by lands of A. P. Sutherlin, on the west by Cleveland Avenue and, on the south and east by lands of J. Norwood and R. Mays Cleveland and being part of the lands purchased by the mortgagor from Mrs. E. M. Cleveland's estate
