SEND GREETING:

WHEREAS, a, the said Belle G. Dillard

in and by her certain promise to pay note in writing, of even date with these presents, due, well and truly indebted to

Chas. McAlister

in the full and just sum of Three Thousand (\$3,000.00)

Dollars, to be paid One (1) year after date and 1921

with interest thereon, from Five full and 12th McAlister at the rate of 5 per cent. per annum, to be computed and paid 2021 full and 12th McAlister

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of five per cent 8

22nd paid Chas. McAlister besides all costs and expenses of collection to be added to the amount due on said note to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage; as in and by the said note, reference being thereunto had, as will more fully appear.)

NOW, KNOW ALL MEN That the said Belle G. Dillard

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Chas. McAlister

according to the terms of said note, and also in consideration of the further sum of Three Dollars, to the said Chas. McAlister

in hand well and truly paid by the said Chas. McAlister

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant,

bargain, sell and release unto the said Chas. McAlister, his heirs and assigns for ever all that certain piece, parcel, lot or tract of land, situate and being in the Second Ward, City of Greenville, in the State and County aforesaid, on East Side of McBee Street, and running the following metes and bounds, to wit:

Beginning at a point on the East side of McBee Street which point is 55 feet from the North East corner of North and McBee Street, and running thence with McBee Street approximately N. 20-48 W. 53 feet 5 inches, thence on a line about parallel with North Street 105 feet more or less, to a stake, thence on a line about parallel with McBee Street 50 feet, 5 inches, more or less; thence with line of property now or formerly owned by Chas. McAlister, approximately N. 17-03 W. 96 feet to the point of beginning, and being the same tract of land surveyed to me by R. M. Ward, deed not yet recorded.
