*Trustee for Hortense Reisenfeld; all that certain tract of
land in the County and State aforesaid, containing 10.2
acres, more or less, conveyed to me by Ellis G. Sedell,
Marsline Sedell Haynesworth and A. S. Sedell, by deed dated
April 29, 1918, recorded in R. M. C. office for Greenville
County in Book 53 at page 15, and described therein as
follows: Beginning at a post oak, dead and gone, thence
N 21 E. 45.64 to stake on old bed of Enoree River;
thence S. 46 1/4 E. 4.50 to stake; thence S 60 1/2 E. 3.70 to
stake at mouth of old run; thence along the
present bed of Enoree River in a southeasterly
direction to stake; thence S 11 3/4 W 85 links to
stake; thence S 37 1/3 E. 3.09 to stake on old river
bed; thence along old river bed to stake; thence
N. 29 1/2 E. 10.2 links to stake; thence N 21 1/2 E. 1.75 to
stake on Enoree River; thence along Enoree River in a
southeasterly direction to stake; thence N 21 3/4 E. 1.47
to stake in place of four, Maples gone; thence S.
52 E. 9.50 to stone, Post oak gone; thence S. 23 W.
19.03 to stone, post oak gone on road leading into
Suncombe Road, thence S. 78 1/4 W. 41.18 to the beginning
being part of the land conveyed to Mrs Sarah A
Crittenden by P. E. Maxwell by deed dated September
14, 1918, recorded in Book 77, page 30.*
