computed and paid **semi-annually**

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who
may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of

ten per cent besides all costs and expenses of collection to be
added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any
part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage; as in and by the said note, reference
being thereunto had, as will more fully appear.)

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant,

bargain, sell and release unto the said **Peoples National Bank as Trustee for Bernice Endel**: All of my
undivided one-half interest in lot of land situate on Prentiss Avenue, City and County of
Greenville, State aforesaid, described on Plat of O.P. Mills property as Lot No. 4, Block L,
said plat being recorded in R.M.C. Office for Greenville County in Plat Book C, page 176,
reference being had to said plat for a more complete description by metes and bounds.

Also all of my undivided one-fourth interest in that certain parcel or lot of land situated
in the Town of West Greenville, corner of Woodside Avenue and the Old Pendleton Road, having
the following metes and bounds: Beginning at the corner of said Woodside Avenue and Pendleton
Road and running thence with said Woodside Avenue 30', more or less, to corner of lot now or
formerly owned by A.C. Batson; thence with his line 50' to corner of lot of A.C. Batson and
E.E. Stone; thence with E.E. Stone's line toward the old Pendleton Road 24' to a corner;

parallel with Pendleton Road in a westerly direction 5', more or less, to a stake on
Pendleton Road; thence with Pendleton Road in a Southern direction 25' to the beginning
corner.
