WHEREAS, I, the said W.D. Workman  
in and by my certain promissory note in writing, of  
even date with these presents, AM well and truly indebted to

in the full and just sum of Three hundred  
Dollars, to be paid one year after date

with interest thereon, from date at the rate of 8 per cent. per annum, to be  
computed and paid semi-annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal  
or interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of

ten per cent besides all costs and expenses of collection to be  
added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any  
part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage; as in and by the said note, reference  
being thereunto had, as will more fully appear.)

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant,  
bargain, sell and release unto the said Jas. M. Richardson, his heirs and assigns: All that certain

piece, parcel or lot of land lying and being situate in Greenville County, State of  
South Carolina, on the Piney Mountain Road, and being known and designated as Lot No.  
27 on a plat of Paris Piney Park, which plat is recorded in the office of R.M.C. for  
Greenville County, in Plat Book H, at pages 19 and 20; reference being here made to that  
plat for a definite and particular description of the said lot.
