WHEREAS, *L. L. Tourtellot*, the said *L. L. Tourtellot*

SEND GREETING:

in and by *Mary* certain *promised to pay*
 note..... in writing, of even date with these presents, *and* *Brandon Corporation*
 in the full and just sum of *Two Thousand (\$2000.00)*
 Dollars, to be paid *on demand*

with interest thereon from *date* at the rate of *6%* per cent. per annum, to be
 computed and paid *semi-annually*

.....until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note.....to become immediately due at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note....., after maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place, and the holder should place, the said note.....or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including 10.....per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness and to be secured under this mortgage as a part of said debt.

NOW, KNOW ALL MEN, That *L. L. Tourtellot* in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said

Brandon Corporation according to the terms of the said note....., and also in consideration of the further sum of Three Dollars to *one*, the said *Brandon Corporation* in hand well and truly paid by the said *L. L. Tourtellot*

at and before the signing of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto the said *Brandon Corporation* all those certain pieces, parcels or lots of land lying and situated in Paris Mountain Township, Greenville County, State of South Carolina, Beginning at an iron pin at the Southwest corner of the *Sam R. Zimmerman* lot and the line of the *J. M. Merchant* lot, and running thence ~~with~~ the line of the said Merchant lot $83-10 W. 281$ feet to an iron pin on old road; thence with old road $71-19-30 E. 124$ feet to an iron pin; thence $71-63-15 E. 106$ feet to a crooked dogwood tree; thence $71-18-10 W. 200$ feet to a stake; thence $71-23-0 W. 275$ feet to a chestnut post; thence across branch $71-78-50 E. 397$ feet to a pin on pile of stones; thence $81-2-20 E. 307$ feet to a fence post, line of property formerly owned by *Sam R. Zimmerman*; thence $71-75-05 W. 68$ feet to a stake; thence $81-3-40 W. 360$ feet to a stake; thence $81-9-20 E. 111$ feet to the beginning corner, and containing 4.56 acres, more or less, according to a plat prepared by *R. E. Dalton*, Engineer, January 1925, being the same land conveyed to *Allen J. Graham* by deed recorded in Volume 92 page 369.

Also all that piece, parcel or lot of land in Paris Mountain Township, Greenville County, State of South Carolina, Beginning at a stake on the West side of Lake Circle Road, corner of Lot No. 37; thence along line of lot No. 37 $83-10 W. 562$ feet to an iron pin on east side of old Hotel Road; thence along the East side of Old Hotel Road, $8.31-30 E. 201$ feet to an iron pin; thence along line of lot No. 39 $71-85-30 E. 450$ feet to a stake on West side of Lake Circle Road; thence along the West side of Road $71-1-30 E. 200$ feet to the point of beginning, same containing 2.18 acres, more or less, surveyed by *R. E. Dalton*, December, 1923, being the same land conveyed to *Allen J. Graham* by deed recorded in Volume 98 page 93.

Also all that piece, parcel or lot of land in Paris Mountain Township, Greenville County, State of South Carolina, Commencing at a stake on the West side of Lake Circle Road, corner of lot No. 36; thence along line of lot No. 36 $71-75$ degrees .05 minutes $W. 306$ feet to an iron pin; thence $8.3-40 W. 260$ feet to a stake; thence $8.1-9-20 E. 111$ feet to line of *J. M. Merchant* lot; thence with said line $71-83-10 E. 281$ feet to Lake Circle Road; thence $71-1-40 E. 260$ feet to beginning, containing 2.13 acres, more or less, being the same lot of land conveyed to *Allen J. Graham* by deed recorded in Volume 98 page 94. Being the same lots of land conveyed to me by deed of *B. E. Seer*, *F. W. Symmes*, *George Norwood* and *W. L.
