

Area offshore, Louisiana. Included in this lateral pipeline section is one 6-inch plug valve at M.P. 15.45 and a 10-inch check valve at M.P. 19.29.

One 4-inch lateral pipe line approximately 0.45 miles in length beginning at the 4-inch riser at Union Oil Platform No. 1 and continuing in a southerly direction to the 4-inch riser at Union Oil Platform No. 3 all in Block 35, Vermilion Area, offshore, Louisiana.

One 16-inch lateral pipe line "C" approximately 10.43 miles in length beginning at the riser of the Mosquito Bay Platform and continuing in a southerly direction to the riser at the Kerr-McGee Platform "D" in Block 28 Ship Shoal Area, offshore Louisiana. Included in this lateral pipeline section is a 16-inch check valve at M.P. 10.35.

One 16-inch lateral pipe line approximately 1.10 miles in length, beginning at Transcontinental's Platform in Block 28 and continuing in a southwesterly direction to the Kerr-McGee D-1 Platform Block 28, all in Ship Shoal Area offshore, Louisiana.

One 4-inch lateral pipe line approximately 2.11 miles in length, beginning at Platform 129A and continuing in a southeasterly direction to Odeco Platform Betty, all in Eugene Island Area, offshore, Louisiana.

One 16-inch lateral pipe line approximately 17.29 miles in length, beginning at Platform in Block 129 Eugene Island Area, and continuing in a southwesterly direction to Platform in Block 23, Marsh Island Area, offshore, Louisiana. Included in this lateral pipe line are two 6-inch lateral valves at M.P. 7.27 and at M.P. 11.27.

One 10-inch lateral pipe line approximately 1.22 miles in length, beginning at Gulf "A" Platform in Block 23, and continuing in a southerly direction to Gulf "B" Platform all in Marsh Island Area, offshore, Louisiana.

PENNSYLVANIA LATERALS

One 30-inch lateral loop line approximately 6.12 miles in length, beginning at Milepost 11.11 on the Marcus Hook Lateral located in Concord Township and continuing in a southerly direction to Milepost 17.20, located in Upper Chichester Township, all in Delaware County, Pennsylvania. Included in this loop section is a lateral valve with double crossover at the beginning of the loop.

One 12-inch (approximately 2.23 miles in length) and 10-inch (approximately 0.03 miles in length) sales lateral, beginning at the header in Compressor Station 535, and continuing in a northwesterly direction to the inlet riser of the United Gas Company M&R Station, all in Wharton Township, Potter County, Pennsylvania. Included in this sales lateral is a 12-inch lateral valve at Compressor Station
