THIS (DEED OF TRUST) MORTGAGE Made this fifteenth day of November, in the year 1927, by and between

of the County of Greenville State of South Carolina, hereinafter designated as First Parties; and The South Carolina National Bank of Charleston, S.C., Greenville Branch, Greenville, S.C. Trustee and American Bank and Trust Company of Greenville, S.C., Bank of Charleston, S.C., Nat'l Bk. of Charleston, S.C. Branch, Greenville, S.C. and Union Trust Company of Maryland, a Corporation duly incorporated under the laws of the State of Maryland and having its principal place of business in the City of Baltimore, in the State of Maryland, as Trustees, and hereinafter designated as Second Parties, (said American Bank and Trust Company of Greenville, S.C., one of the Second Parties is hereinafter designated and referred to as Local Trustee and Union Trust Company of Maryland, one of the Second Parties, is hereinafter designated and referred to as Foreign Trustee).

WHEREAS the First Parties have received a certain loan of money evidenced by the notes herein described and have agreed to secure the said notes by this Mortgage and Trust.

NOW THEREFORE THIS (DEED OF TRUST) MORTGAGE WITNESSETH: That in consideration of the sum of One Dollar (\$1.00) paid to the First Parties by the Second Parties, the receipt whereof is hereby acknowledged by the said First Parties and in consideration of the acceptance of the Second Parties of the trusts hereinafter set forth, which acceptance of the Second Parties is evidenced by their authentication of the said notes, the First Parties hereby grant and convey unto the Second Parties, their survivor and successor or successors, certain real estate situated in the County of Greenville, State of South Carolina, and described as follows, that is to say;

all that certain parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, outside the corporate limits of the City of Greenville, on the South side of McCarey Street, being known and designated as Lot No. 4 of Elizabeth Heights as shown on a plat recorded in the R.M.C. Office for Greenville County in Plat Book "F" at page 298, and having according to a plat thereof prepared by Dalton & Nevel, Engineers, December, 1927, the following metes and bounds, to-wit:

Beginning at an iron pin on the South side of McCarey Street which said iron pin is 69.2 ft. East of the South-east intersection of Edwards and McCarey Streets, and running thence along the South side of said McCarey Street S. 76-150.55 ft. to an iron pin joint corners of Lots Nos. 4 and 5; thence along the joint line of said lots Nos. 4 and 5, S. 15-00 ft. 163 ft. to an iron pin in the rear line of lot No. 4 and 5; thence along the rear line of said Lot No. 4 and 5, N. 76-15-30 ft. 58.8 ft. to an iron pin, joint corner of Lots Nos. 3 and 4; thence along the joint line of said Lot No. 3 and 4 N. 16-30 ft. 163 ft. to the point of beginning.

And the said First Parties covenant with the said Second Parties that the said First Parties are indefeasibly seized in fee simple of said premises and have full power and lawful right to convey the same as aforesaid, and that the same is free, clear, discharged and unencumbered of and from all former and other grants, titles, charges, estates, judgments, taxes, tax titles, or tax certificates, liens, assessments and encumbrances of what nature and kind soever; and the said First Parties do fully warrant the title to the said premises and will defend the same against the lawful claims of all persons whomsoever, BUT IN TRUST AND CONFIDENCE NEVERTHELESS for the following uses and purposes, to-wit:

(a) To secure to the holder or holders thereof, equally and ratably and without preference or priority the one over the other, without preference or priority of principal over interest or of interest over principal or of any installment of interest over any other installment of interest, the payment of a certain promissory negotiable note of the First Parties of even date herewith in the amount of Twenty Six Hundred
