Beginning at a pin on pin at the Southwestern corner of an angle of Hampton Avenue Extension, and near the corporate limits of the City of Greenville, and running thence along said Hampton Avenue Extension S. 18° 06' 21.114.3 feet to a iron pin on line of property now or formerly owned by Cula Summers (Summers); thence along said Summers line N. 71° 15' 21.144 ft to an iron pin on the east side of Michael Street thence along the east side of said Street N. 18° 06' E. 174.3 feet to an iron pin at intersection of said Michael Street with Hampton Avenue Extension; thence S. 49° 75' E. 157.2 feet to the point of beginning, and being lots Nos. 1 and 2 and a part of No. 3, according to plat recorded in the office of the Register of Mesne Conveyances for Greenville County, South Carolina in Plat Book "A" at page 141, and being the same as conveyed to me by T. J. Summers, deed dated June 12, 1913 and recorded in aforesaid Register's office in Volume 18 at page 418, and by C. Inman, Master, deed dated December 8, 1915, and recorded in said Register's office in Volume 14, at page 449.

Also all that other piece, parcel, lot or tract of land, lying, situate and being in Ward One, City of Greenville, in the State and County aforesaid, and being known and designated as lot No. 3, according to plat recorded in the Register of Mesne Conveyances for Greenville County, South Carolina, in Plat Book "A" at page 89, and having the following metes and bounds; to wit:
