NOW, KNOW ALL MEN, That Harriet A. Aycroft in consideration of the said debt and sum of money as aforesaid and for the better securing the payment thereof to the said PIEDMONT SAVINGS AND TRUST COMPANY, according to the condition of the said note or obligation, and also in consideration of the further sum of FIVE DOLLARS to me, the said Harriet A. Aycroft.

in hand well and truly paid to the said PIEDMONT SAVINGS AND TRUST COMPANY, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged) have granted, bargained, sold and released, and by these presents, do grant, bargain, sell and release unto the said PIEDMONT SAVINGS AND TRUST COMPANY, all that tract or parcel of land, situated in County of Greenville, State of South Carolina, and described as follows:

*Adjoining land of Davidson and others, situate in the north east corner of the Parker Land Company Lands shown on plat #. 2 made by A. S. Bedell dated April, 1914 and bounded and described as follows: In Tract 10, Beginning at a point in the corner of the Davidson Lot. And in the line of the Davidson tract running thence with the said Davidson line S. 49.77 E. 5-56 feet, more or less to a gum tree on Davidson's corner and branch; thence following the general direction of the branch as follows: S. 46-00 W. 148.8 feet to a stake; thence S. 67-31 W. 239.3 to a stake; thence S. 43-11 W. 176.4 feet to a stake; thence S. 35-58 W. 164.3 feet to a stake on north east corner of tract 91; thence with the line of tract 91, N. 5-8-45 W. 5-66 feet to a stake, the north west corner of tract 91 and in the middle of the Davidson lot; thence with the center of said lot N. 78-0 E. 36 feet to a stake; thence N. 5-8-10 E. 269 feet to a stake; thence still the center of the Davidson lot N. 43-0 E. 500 feet to the beginning, containing 7.66 acres more or less. Being the same lot of land conveyed to me by The Parker Land Company by deed, dated October 17, 1916 and recorded in the R. M. B. Office for Greenville County in Vol. 37 at page 469.*
