

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Mrs Alma Campbell
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, the said Mrs Alma Campbell
in and by my certain note or obligation, bearing date the 6th day of January 1927.

I am indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Eleven Hundred Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 6th day of January A. D. 1927, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

I the said Mrs Alma Campbell shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of January 1927, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of

Eighteen and 34/100 Dollars, (Eleven Dollars, being the regular monthly installment payable on Eleven Shares of Stock, and Seven and 34/100 Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the

sum of Sixteen and 86/100 Dollars, (Eleven Dollars, being the regular monthly payment of said stock and Five and 86/100 Dollars, being the monthly interest on balance due); for the next twenty months the sum of

Fifteen and 40/100 Dollars, (Eleven Dollars, being the regular monthly payment of said stock and Four and 40/100 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of

Thirteen and 94/100 Dollars, (Eleven Dollars, being the regular monthly payment on said shares of stock and Two and 94/100 Dollars, being the monthly interest on balance due); for the next twenty months pay the

sum of Twelve and 47/100 Dollars, (Eleven Dollars, being the regular monthly payment on said shares of stock and One and 47/100 Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said Eleven shares of stock and the certificates thereof, the amount at such time paid shares by me to be credited as a payment upon the advance or loan made me the said

Mrs Alma Campbell and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against me the said Mrs Alma Campbell in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the conditions hereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I the said Mrs Alma Campbell in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me the said

Mrs Alma Campbell in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land situated in the County of Greenville, State of South Carolina, and described as follows:

All that certain piece, parcel or lot of land situate, lying and being in the County and State aforesaid, in a vicinity known as "City View", and being the rear portions of lots Nos. 89 and 90 as shown on plat of Morgan Hill, recorded in the R.M.C. Office for said County in Plat Book A, at page 70, having the following metes and bounds, to-wit:
Beginning at a point on Summit Street on line of lot No. 89 and running thence with Summit Street 69 feet to the rear corner of said lot on said street; thence with rear line of lots Nos. 89 and 90 to rear northeast corner of lot No. 90, being 114 feet, more or less; thence with northern line of lot No. 90, 69 feet to a point in said line; thence a straight line 114 feet, more or less, to the beginning corner; and being the same land conveyed to me by W.R. Smith by deed dated October 28, 1926, recorded in the R.M.C. Office for said County in Deed Book 104, at page 276.
