

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Frank White, Jr of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, the said Frank White, Jr in and by my certain note or obligation, bearing date the 24th day of February 1928

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Fourteen Hundred and 7/100 (\$1400.00) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 24th day of February A. D. 1928, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that I

the said Frank White Jr shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of March 1928, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Twenty-three and 3/100 (\$23.34)

Dollars, (\$14.00) Dollars, being the regular monthly installment payable on the 14 Shares of Stock, and Nine and 3/100 (\$9.34) Dollars, being the monthly interest on the advance (or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Twenty-one and 4/100 (\$21.46) Dollars, (\$14.00) Dollars, being the regular monthly payment on said stock, and \$7.46 Dollars, being the monthly interest on balance due); for the next twenty months the sum of Fifteen and 6/100 (\$15.60) Dollars, (\$14.00) Dollars, being the regular monthly payment on said stock and \$5.60 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Seventeen and 7/100 (\$17.74) Dollars, (\$14.00) Dollars, being the monthly payment on said shares of stock and

Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Fifteen and 8/100 (\$15.86) Dollars, (\$14.00) Dollars, being the monthly payment on said shares of stock and \$1.86 Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said 14 shares of stock and the certificate thereof, the amount at such time paid shall be credited as a payment upon the advance or loan made, the said

and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against me the said Frank White, Jr in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN That I, the said Frank White, Jr in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me

the said Frank White Jr in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

Composed of two lots, one on Manley Street, in the City of Greenville, and known as Lot No. 3 of the parcel conveyed to C. H. Crockett, by Mary Croft, as described in the deed recorded in Deed Book 899, Page 401, P. M. C. Office for Greenville County, and having the following metes and bounds: Beginning at a stake on Manley Street 95 ft. from corner of Manley and Gun Sts, and running thence N. 12-30 W. 50 feet with Manley Street to a stake; thence S. 77-30 W. 146 feet to a stake; thence S. 12-30 E. 50 feet to a stake; thence N. 77-30 E. 146 feet to the Beginning corner and being the same lot of land conveyed to me by Wm. Goldsmith by deed dated October 23, 1919, and recorded in Deed Book 56, Page 150, P. M. C. Office for said Greenville County.

Also: All that other lot of land in the City of Greenville, South Carolina, Beginning at Lula Thompsons Corner on Green Avenue and running thence with Green Avenue 42 feet to Adolph Speyers corner; thence S. 77 W. 139 feet; thence N. 13 E. 39 feet to Lula Thompsons corner; thence S. 77 E. 150 feet to the Beginning corner. This being the same land conveyed to Frank White Jr. by Thos. D. Charles by deed dated June 21st, 1913, and recorded in Vol. 20, Page 121 P. M. C. office for Greenville County.
