TO ALL WHOM THESE PRESENTS MAY CONCERN: *I, Luther Foster, Crawley Foster, J. O. Foster, R. M. Foster, Lillie Foster and Beulah Foster Raither, mortgagees*

of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting: WHEREAS, *we*, the said *Luther Foster, Crawley Foster, J. O. Foster, R. M. Foster, Lillie Foster and Beulah Foster Raither*

in and by *our* certain note or obligation, bearing date the *20th* day of *April* 192 *8* indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of *Five Hundred (\$500.00)* Dollars,

with interest thereon at the rate of eight per centum per annum, payable monthly, from the *20th* day of *April* A. D. 192 *8*, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that *we*

the said *Luther Foster, Crawley Foster, J. O. Foster, R. M. Foster, Lillie Foster, Beulah F. Raither* shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of *May* 192 *8*, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of *Seven & 92/100 (\$7.92)*

Dollars, (*Five \$5.00*) Dollars, being the regular monthly installment payable on the *five* Shares of Stock, and *Two & 92/100 (\$2.92)* Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of *Seven & 33/100 (\$7.33)* Dollars, (*Five \$5.00*) Dollars, being the regular monthly payment on said stock and *Two & 33/100 (\$2.33)* Dollars, being the monthly interest on balance due);

for the next twenty months the sum of *Seven & 75/100 (\$7.75)* Dollars, (*Five \$5.00*) Dollars, being the regular monthly payment on said stock and *One & 75/100 (\$1.75)* Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *One & 17/100 (\$1.17)* Dollars, (*Five \$5.00*) Dollars, being the monthly payment on said shares of stock and *Five \$5.00* Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *Five \$5.00* Dollars, being the monthly payment on said shares of stock and *Five \$5.00* Dollars, being the monthly interest on balance due.)

and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against *us*, the said *Luther Foster, Crawley Foster, J. O. Foster, R. M. Foster, Lillie Foster and Beulah F. Raither* in accordance with the Charter, By-Laws, Rules and Regulations, and by the said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That *we* the said *Luther Foster, Crawley Foster, J. O. Foster, R. M. Foster, Lillie Foster and Beulah F. Raither* in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to *us*
