

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, John B. Barker of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, John B. Barker in and by my certain note or obligation, bearing date the 11th day of May 1928

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of One Thousand (\$1,000.00) Dollars,

with interest thereon at the rate of eight per centum per annum, payable monthly, from the 11th day of May A. D. 1928, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

I, the said John B. Barker shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of May 1928, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Fifteen + 83/100 (\$15.83) Dollars, (Ten (\$10.00) Dollars, being the regular monthly installment payable on the Five (5) Shares of Stock, and Five + 83/100 (\$5.83) Dollars, being the monthly interest on the advance (or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Fourteen + 67/100 (\$14.67) Dollars, (Ten (\$10.00) Dollars, being the regular monthly payment on said stock and Four + 67/100 (\$4.67) Dollars, being the monthly interest on balance due); for the next twenty months the sum of Thirteen + 51/100 (\$13.51) Dollars, (Ten (\$10.00) Dollars, being the regular monthly payment on said stock and Three + 51/100 (\$3.51) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Twelve + 33/100 (\$12.33) Dollars, (Ten (\$10.00) Dollars, being the regular monthly payment on said shares of stock and Two + 33/100 (\$2.33) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Eleven + 17/100 (\$11.17) Dollars, (Ten (\$10.00) Dollars, being the regular monthly payment on said shares of stock and One + 17/100 (\$1.17) Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said ten shares of stock and the certificate thereof, the amount at such time and shares by me to be credited as a payment upon the advance or loan made me, the said

and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against me the said John B. Barker in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW KNOW ALL MEN, That I, the said John B. Barker in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five (\$5.00) Dollars to

Barker in and well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

John B. Barker Greenville Township, in Fallis Annex and being known and designated as Lots Nos. 5, 6 and 7 as shown on a plat of the property of Mrs. L. G. Barker, made by Dalton and Nevel, March, 1927, and having the following metes and bounds, to-wit:

Beginning at a stake on White Circle, joint corner of lots 4 and 5, and thence running along White Circle N. 68-38 W. 100 feet to a stake; thence N. 59-03 W. 100 feet to a stake; thence N. 39-15 E. 103 feet to a stake; thence N. 17-14 W. 100.8 feet to a stake on the corner of Lots Nos. 7 and 16; thence along the joint line N. 65 E. 266.5 feet to a stake on the rear corner of Lot No. 8; thence along the line of Lot Nos. 8, 7 and 6 S. 23-40 E. 200 feet to a stake on the rear corner of Lots Nos. 3, 4 and 6; thence along the line of Lots Nos. 4 and 6 S. 65 W. 80 feet to a stake; thence S. 8-25 E. 162 feet to a stake on White Circle at the beginning corner.
