WHEREAS, *I*, the said *W J Forrester*
in and by *my* certain *Am* note in writing, of

in the full and just sum of *Seven hundred*
Dollars, to be paid *one year from date*

with interest thereon, from *date* at the rate of *8* per cent. per annum, to be
computed and paid *Annually*

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal
or interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who
may sue thereon and foreclose this mortgage; said note further providing for an attorney

besides all costs and expenses of collection to be

bargain, sell and release unto the said *G M Henson* all that certain tract

Tyger river, containing 85 1/2 acres more or less
except or minus about 1/2 acres across the creek,
being the same tract of land less the said 1/2 acres
across the creek, as described in deed given me
by *W. J. Holtzclaw* and *N. D. Franke* dated Aug.
17th, 1909 and recorded in office of R M C. for
Greenville County in Vol. 8 Page 230 and for
a full description of said land reference is
hereby expressly made to said deed
