part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage; as in and by the said note, reference being

bargain, sell and release unto the said **Minnie Winn Allison, her heirs and assigns. All that piece, parcel or lot of land situate on Buckner Street in the City and County of Greenville in said State. Beginning at an iron pin on said Street 46 feet and 2 inches from a 20 foot back street, and runs thence S.E. 116 feet to an iron pin on Lidie Williams line; thence S.W. course 50 feet to an iron pin; thence N.W. course 116 feet to an iron pin on Buckner Street; thence N.E. with said Street 50 feet to the beginning corner, being the same lot conveyed to me by deed recorded in the office of R.M.C. for Greenville County in Vol. E, page 202.**

Also, all that piece, parcel and lot of land, situate, lying and being in Ward No. 1 of the City of Greenville and in the State and County aforesaid, having the following metes and bounds, to-wit: Beginning at a stake corner of Mrs. J.B.
