or interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who
may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee

Forty dollars besides all costs and expenses of collection to be

bargain, sell and release unto the said H.K. Townes, Attorney, for heirs and assigns forever: "All that

piece, parcel or lot of land Greenville Township, Greenville County, State of South
Carolina, being lots Nos. 1 and 2 of property of Eliza T. Looper as shown by plat made by
R.E. Dalton, December 1924, and described as follows:

Lot No. 1: Beginning at corner of Looper and Gordon Streets, and running thence with
Gordon Street 71-17 W. 51.5 feet to corner of lot #2; thence with line of lot 2 N. 1608
W. 149.8 feet to point in line of lot 39; thence with line of lot 39 N. 71-17 E. 69.4 feet
to Looper Street; thence with said Looper Street S. 9-18 E. 151.8 feet to the beginning
corner.

Also Lot No. 2: Beginning on Gordon Street at corner of lot No. 1 and running thence with
