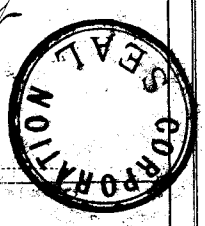
AND IT IS AGREED, by and between the said parties that the said mortgagor *is* to hold and enjoy the said Premises until default of payment shall be made.
