We, Charlie Willis and Lora Willis SEND GREETING:

WHEREAS, we, the said Charlie Willis and Lora Willis  
in and by our certain promissory note in writing, of  
even date with these presents, are well and truly indebted to

in the full and just sum of One thousand  
Dollars, to be paid one year after date

with interest thereon, from date at the rate of eight per cent. per annum, to be  
computed and paid semi-annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of

ten per cent besides all costs and expenses of collection to be added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage; as in and by the said note, reference being thereunto had, as will more fully appear.)

NOW, KNOW ALL MEN, That We the said Charlie Willis and Lora Willis  
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said

according to the terms of said note, and also in consideration of the further sum of Three Dollars, to us, the said

Charlie Willis and Lora Willis  
in hand well and truly paid to the said

A.D.L. Barksdale  
at and before the signing of these Presents, the receipt whereof hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said A.D.L. Barksdale, his heirs and assigns forever:

"All that piece, parcel or lot of land situated lying and being in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, on John Street having the following metes and bounds: Beginning at a point on the Northeast side of John Street, 113 feet and 1 inch northwest of the lot now or formerly owned by H.G. Simpson, and running thence in a northeast direction, parallel with line of said Simpson lot, 156 feet, more or less, to lot of Mrs. W.B. Boyd; thence in a northwest direction, parallel with John Street and with line of Mrs. Boyd's lot 50 feet and 1 inch to a corner; thence in a southwest direction, parallel with line of the said Simpson lot, 156 feet, more or less, to a corner of said John Street; thence in a southeast direction with said John Street 50 feet and 1 inch to the beginning corner; and, being the same conveyed to us by deed of E.L. Hughes, Jr. to be recorded".
