

AGREEMENT FOR EXTENSION OF LOAN NO. *A-93267*

WHEREAS, there remains unpaid on a certain note executed and delivered by *E. G. McCain* to *The Prudential Insurance Company of America*, secured by a *Mortgage* upon real estate in *Greenville* County, *South Carolina*, dated *November 6th*, 19*22*, and recorded in said County on *November 8th*, 19*22*, in Volume *123* of *Mortgages* on Page *18*, in the sum of *Four Thousand (\$4,000.00)* Dollars, with interest from *November 6th*, 19*27*, and,

WHEREAS, title to the mortgaged premises is now vested in *E. G. McCain* subject to said *Mortgage* and,

WHEREAS, the said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

NOW, THEREFORE, the said *E. G. McCain* hereby agree to pay the principal sum remaining due as aforesaid as follows: *on November 6, 1932;*

with interest thereon from *November 6th*, 19*27*, to *November 6th*, 19*32* at the rate of *five and one half* per cent. per annum, payable *semi* annually; and with interest after maturity as set forth in said note.

PREPAYMENT PRIVILEGE: *Privilege is given to make payments of one hundred \$100.00 Dollars or any multiple thereof, on the principal at any interest payment date*

And the parties to this agreement hereby consent to said extension and agree that said *Mortgage* shall continue a first lien upon said premises, and that said note and *Mortgage* and all their covenants and conditions shall remain in force except as herein modified.
