unto the said The Liberty Life Insurance Company, its successors and assigns forever, all that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, being Lot no 14 in subdivision known as South Cherokee Park, said lot has a frontage on Keeve Avenue of 60 feet and runs back to an alley to a depth of 172 feet, for a more particular description reference to a plat thereof is hereby granted, said plot is recorded in the R. M. C. Office for Greenville County in Plat Book A, at Page 130.

All that certain lot or parcel of land situated in Ward One of the City of Greenville, County and State aforesaid on the North side of West Earle Street, said lot having a frontage of 65 1/2 feet on West Earle Street and a depth of 200 feet in parallel lines and is known and designated as Lot no 42, Section "C" as shown by Plat of Stone Land Company made by J. E. Serrine May 21, 1909, and recorded in office of R. M. C. for Greenville County in Plat Book "A" at Page 337 and following pages.

All those three lots or parcels of land situated in Greenville County, State of South Carolina known and designated as Lots nos 4, 5 and 6 as is shown by Plat recorded in the Office of R. M. C. for Greenville County in Plat Book "B" at page 86, and according to said Plat more particularly described as follows: Beginning at a point on the Eastern side of Augusta Street at joint corner of Lots 3 and 4 as shown on said Plat and running thence along said side of Augusta Street S. 6-15 W. 60 feet, more or less, to an iron pin; thence S. 82 1/2 E. 80 feet to iron pin on Western side of twelve foot alley as shown by Plat, thence along said side of said alley N. 6-15 E. 60 feet to point at rear joint corner of lots 3 and 4, thence along the joint line of said lots N. 82 1/2 W. 80 feet to the beginning corner.

Also, the entire 12 foot alley in the rear of said three lots and Lots nos 1, 2 and 3 as shown by said plat. Subject, however, to such interest as W. M. Webster and Thomas L. Lewis their heirs and assigns may have in the use of said 12 foot alley.
