ALL that certain 44,000 volt electric power line and rights of way running from the Town of Fair Forest in the County of Spartanburg and State of South Carolina, to the sub-station located in the City of Greer in the County of Greenville, South Carolina, and all poles, and lines of wire in connection with said transmission line, together with the complete out-door sub-station equipment, including transformers, lightning arresters, disconnecting switches, and other equipment pertaining to this sub-station.
