thereof, be collected by an attorney or by legal proceedings of any kind, all of which is secured under this mortgage); as in and by the said note, reference being

assigns forever: all those two (2) certain pieces,
parcels or lots of land situated, lying and being
in Greenville Township, Greenville County, State of
South Carolina, just outside the limits of the City
of Greenville, on Foster Street and having the fol-
lowing metes and bounds according to a plat
made by N. D. News, March 16th, 1914, which plat
is recorded in the R. M. C. Office for Greenville
County in Plat Book "C" at page 226, to-wit:

Beginning at an iron pin on the south side
of Foster Street, corner of lots 17+18, and running
thence along joint line lots 17+18 about S. 36° 4
N. 93.4 feet, more or less, to an iron pin in line
lots 1, 2, + 3; thence with rear line of lots 2+3;
76.3 feet more or less, to an iron pin, corner
