piece, parcel or lot of land situate in Ward One of the City of Greenville corner of Park Avenue and Atwood Street and having the following metes and bounds to wit: Beginning at an iron pin at intersection of Atwood Street and Park Avenue, and running thence with Atwood Street S. 48° 0' W. 58.8 to an iron pin corner of lot #7, and running thence with line of lot #7, S. 42° 0' E. 125 feet to an iron pin running thence N. 14° 24' W. 118 feet to Park Avenue theee with Park Avenue N. 75° 40' W. 69 feet to the point of beginning being part of lot #8 fronting on Ward Park Avenue and Atwood Street, a lot of which is recorded in Plat Book #6 at page 132, in the office of R.
