hereof, until each and every share in the said Association shall reach the value of ONE HUNDRED DOLLARS, and also for

*Ten per cent*

attorney's fees, in case of suit or collection by or through

an attorney, which, in addition to the said debt, is hereby secured and made a lien on the premises as in and by the said Bond and Condition thereof, reference being had thereunto, will more fully appear.

NOW, KNOW ALL MEN, That *I*, the said *A. G. Wilson*

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING AND LOAN ASSOCIATION, of Greer, Greenville County, South Carolina, according to the condition of said Bond; and, also, in consideration of the further sum of THREE DOLLARS, to *me* to said *A. G. Wilson*

in hand, well and truly paid by the said Citizens Building and Loan Association of Greer, Greenville County, South Carolina, at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, the said *A. G. Wilson*

have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said Citizens Building and Loan Association, of Greer, Greenville County, South Carolina, all that lot of land, in said State and County, in the City of Greer, on the *East* side of *Morrow* Street.

*Beginning at an iron pin on Morrow Street the J. E. Sturpley corner, and running thence along said Street N. 11-15 E. 100 feet to an iron pin, N. M., corner of J. M. Jew's lot; thence S. 78-30 E. 350 feet to an iron pin on south side of a branch on J. M. Braunon's line, thence S. 12-30 W. 43 feet to an iron pin on north side of said branch, J. M. Braunon's corner; thence S. 4-00 W. 106 feet to an iron pin, O. M.; thence N. 84-20 W. 172 feet to an iron pin by a fence; thence N. 11-00 E. 64 feet to an iron pin, O. M.; thence N. 78-45 W. 180 feet to the beginning, bounded by lands of J. M. Jew, J. M. Braunon and others, and being the same lot of land conveyed to me by D. H. Bryant.*
