per cent. per annum, payable weekly,

the payment whereof the said party of the first part is anxious to secure:

Now, therefore, in consideration of the premises, and in further consideration of one dollar to him in hand paid, the receipt whereof is hereby acknowledged, the said party of the first part has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the said party of the second part all

that certain piece, parcel and lot of land lying in Greenville County, in the State aforesaid, as follows, to-wit:

In Greenville Township, being a part of the lands of said company known as Riverside, said plat being known and designated on a plat of said lands made by Carter & Pringle, Surveyors (which plat is of record in said Office) as lot no. 8 of Block 5, fronting 50 feet on Palmetto Avenue and running back to a depth of 110 feet, being more particularly described as follows: Beginning at a stake on Palmetto Avenue, joint corner lots 8 and 9, and running thence with said Avenue N.E. 45° W. 50 feet to a stake at northeast corner of intersection of Palmetto Avenue and Marion Street, thence with Marion Street in a northerly direction 110 feet to a stake on an alley thence with said Alley S.E. 45° E. 50 feet to corner lot 9, thence with said line, lots 9 and 8, 110 feet to stake on Palmetto Avenue, the point of beginning.
