And I do hereby bind Myself, my Heirs, Executors and Administrators, to warrant and forever defend, all and singular the said premises unto the said Colonia Company, its successors Heirs and Assigns, from and against Myself and my Heirs, Executors, Administrators and Assigns, and every person whomsoever lawfully claiming, or to claim the same, or any part thereof.

And the said Mortgagor..... agree..... to insure the house and buildings on said lot in a sum not less than.....
