WHEREAS, *C. M. Reese*, the said *C. M. Reese* in and by *my* certain note or obligation, bearing date the *11th* day of *October* 192*8*

Twenty-nine + 33/100 (\$29.33) Dollars, (*29.33*) Dollars, being the regular monthly payment on said stock and *Twenty* Dollars, (*20.00*) Dollars, being the monthly interest on balance due);

for the next twenty months the sum of *Twenty-four + 67/100 (\$24.67)* Dollars, (*24.67*) Dollars, being the regular monthly payment on said stock and *Seven (\$7.00)* Dollars, (*7.00*) Dollars, being the monthly interest on balance due);

for the next twenty months pay the sum of *Twenty-four + 67/100 (\$24.67)* Dollars, (*24.67*) Dollars, being the monthly payment on said shares of stock and *Four + 33/100 (\$4.33)* Dollars, (*4.33*) Dollars, being the monthly interest on balance due);
