TO ALL WHOM THESE PRESENTS MAY CONCERN:

of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, *Lillie Faubion*, the said *Lillie Faubion* #8107,
 in and by *myself* certain note or obligation, bearing date the *30th* day of *October* 192 *8*
 indebted unto *The Carolina Loan and Trust Company*, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of *two hundred fifty (\$150.00)* Dollars,
 with interest thereon at the rate of eight *per centum* per annum, payable monthly, from the *30th* day of *October* A. D. 192 *8*
 according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that *Lillie Faubion*
 the said *Lillie Faubion* shall pay or cause to be paid to the said Company, by its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of *November* 192 *8*, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of *Sixteen + 63/100 (\$16.63)* Dollars, (*10.50*) Dollars, being the regular monthly installment payable on the *ten + one-half* Shares of Stock, and *Six + 13/100 (\$6.13)* Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of *Four + 90/100 (\$4.90)* Dollars, (*10.50*) Dollars, being the regular monthly payment on said stock and *Four + 90/100 (\$4.90)* Dollars, being the monthly interest on balance due); for the next twenty months the sum of *Fourteen + 18/100 (\$14.18)* Dollars, (*10.50*) Dollars, being the regular monthly payment on said stock and *Three + 68/100 (\$3.68)* Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *Twelve + 95/100 (\$12.95)* Dollars, (*10.50*) Dollars, being the monthly payment on said shares of stock and *Two + 45/100 (\$2.45)* Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *Eleven + 73/100 (\$11.73)* Dollars, (*10.50*) Dollars, being the monthly payment on said shares of stock and *One + 23/100 (\$1.23)* Dollars, being the monthly interest on balance due.)
 Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said *10 1/2* shares of stock and the certificate thereof, the amount at such time paid shares by *me* to be credited as a payment upon the advance or loan made *me*, the said *Lillie Faubion* and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against *me* the said *Lillie Faubion* in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That *Lillie Faubion* the said *Lillie Faubion* in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to *me* the said *Lillie Faubion* in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

All that certain lot of land situate, lying and being in Greenville Township, County and State aforesaid, and being designated as Lot No. 9 of the W. H. McLaha property, as shown on a plat of same recorded in Plat Book, F, at page 33, and having the following metes and bounds:
 Beginning at an iron pin on the north side of Cobb Street, and at the joint corner of Lots Nos. 9 and 10, said pin being a distance of 171.8 feet from the intersection of Donnan Street and Cobb Street, and thence running with the joint line of Lots Nos. 9 and 10 N. 51-30 W. 123 feet to an iron pin; thence N. 51-20 E. 7.6 feet to an iron pin in the rear line of Lot No. 5; thence S. 51-30 E. 129.2 feet to an iron pin on Cobb Street; thence along Cobb Street S. 38-40 W. 157 feet to the beginning corner, being the same plot conveyed to Lillie Faubion by W.
