I, C. C. Good of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, the said C. C. Good in and by my certain note or obligation, bearing date the 26th day of February 1929

incorporated under the laws of such State), in the sum of Two Thousand (\$2,000.00) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 26th day of February A. D. 1929 according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

I the said C. C. Good shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of March 1929, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Thirty one & 67/100 (\$31.67) Dollars, (\$20.00

Dollars, being the regular monthly installment payable on the twenty Shares of Stock, and Eleven & 67/100 (\$11.67) Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Twenty-nine & 33/100 (\$29.33) Dollars, (\$20.00

Dollars, being the regular monthly payment on said stock and Nine & 33/100 (\$9.33) Dollars, being the monthly interest on balance due); for the next twenty months the sum of Twenty-seven (\$27.00) Dollars, (\$20.00

Dollars, being the regular monthly payment on said stock and Seven (\$7.00) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Twenty-four & 67/100 (\$24.67) Dollars, (\$20.00

Dollars, being the monthly payment on said shares of stock and Four & 67/100 (\$4.67) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Twenty-two & 33/100 (\$22.33) Dollars, (\$20.00

Dollars, being the monthly payment on said shares of stock and Two & 33/100 (\$2.33) Dollars, being the monthly interest on balance due.) Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said twenty shares of stock and the certificate thereof, the amount at such time paid shares by me to be credited as a payment upon the advance or loan made me, the said

Good in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me

Good in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

being known and designated as lot no. 36 according to a plat of Thomas M. Walker Company, recorded in Plat Book C, at page 146, R. M. C. Office for Greenville County. Said lot has a frontage on Chicago Street of twenty-five (25) feet and runs back in parallel lines a depth of sixty (60) feet more and has thereon a one-story brick building and is the same lot conveyed to me, C. C. Good by Thomas M. Walker by deed dated July 8, 1928, and recorded in Volume 69, page 18, R. M. C. Office for said Greenville County.
