

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

We, William Edwards and Lucile Edwards of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, we, the said William Edwards and Lucile Edwards in and by my certain note or obligation, bearing date the 19th day of September 1929

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Eight Hundred (\$800.00) Dollars,

with interest thereon at the rate of seven per centum per annum, payable monthly, from the 19th day of September A. D. 1929 according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that we

the said William Edwards and Lucile Edwards shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of October 1929, and on the 20th or before the end of each month hereafter for twenty successive months, the sum of Twelve & 6/100 (\$12.67)

Dollars, (being the regular monthly installment payable on the Eight Shares of Stock and Four & 6/100 (\$4.67) Dollars, being the monthly interest on the advance or loan) until there have been paid two (2) monthly payments, and shall for the next twenty months pay the sum of Eleven & 7/100 (\$11.73) Dollars, (being the regular monthly payment on said stock and Three & 7/100 (\$3.73) Dollars, being the monthly interest on balance due);

for the next twenty months the sum of Ten & 8/100 (\$10.80) Dollars, (being the regular monthly payment on said stock and Two & 8/100 (\$2.80) Dollars, being the monthly interest on balance due);

for the next twenty months pay the sum of Nine & 8/100 (\$9.87) Dollars, (being the regular monthly payment on said stock and One & 8/100 (\$1.87) Dollars, being the monthly interest on balance due);

for the next twenty months pay the sum of Eight & 9/100 (\$8.93) Dollars, (being the regular monthly payment on said stock and One & 9/100 (\$1.93) Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said Eight shares of stock and the certificate thereof, the amount at such time paid shares by me to be credited as a payment upon the advance or loan made me, the said

William Edwards and Lucile Edwards and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against me, the said William Edwards and Lucile Edwards

in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That we, the said William Edwards and Lucile Edwards in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to come

the said William Edwards and Lucile Edwards in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the making and giving of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina and described as follows:

Situate on Palmer Street, beginning at a stake on Palmer Street, and running thence along said Street 36 feet; thence with an alley 136 feet to an unnamed Street; thence with the last mentioned Street 50 feet to the corner of Lot no 8; thence along the line of that lot 135 feet to the beginning, being designated as Lot no 7, according to a plat made by C. M. Furman Jr., February 17, 1924, and being the same lot conveyed to the said Mrs. A. C. Davis June 7, 1923 by deed recorded in Volume 88, page 242, R. M. C. Office for Greenville County.
