Mary L. Wood of Greenville, in the County of Greenville, and the State of South Carolina, send greeting.

WHEREAS, *my* the said *Mary L. Wood* in and by *my* certain note or obligation, bearing date the *11th* day of *October* 192 *8*

incorporated under the laws of such State), in the sum of *Seven Hundred Fifty (\$750.00)* Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly from the *11th* day of *October* A. D. 192 *8*

according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that *Mary L. Wood* the said *Mary L. Wood* shall pay or cause to be paid to the said

Company, or its certain attorneys, successors or assigns, at Greenville City, aforesaid, monthly, on the 20th or before the end of the month of *November* 192 *8*, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of

Eleven + 88/100 (\$11.88) Dollars, (*\$7.50* Dollars, being the regular monthly installment payable on the *Seven Four* Shares of Stock and *Four + 38/100 (\$4.38)*

Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of *Eleven (\$11.00)* Dollars, (*\$7.50*

Dollars, being the regular monthly payment on said stock and *Three + 50/100 (\$3.50)* Dollars, being the monthly interest on balance due); for the next twenty months the sum of *Seven + 13/100 (\$7.13)* Dollars, (*\$7.50*

Dollars, being the regular monthly payment on said stock and *Two + 63/100 (\$2.63)* Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *Seven + 25/100 (\$7.25)* Dollars, (*\$7.50*

Dollars, being the monthly installment on said shares of stock and *One + 75/100 (\$1.75)* Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *Eight + 38/100 (\$8.38)* Dollars, (*\$7.50*

Situate in the Town of West Greenville, on the north side of Perry Avenue, having a frontage on Perry Avenue of Fifty (50) feet and a depth of One Hundred Thirty Five (135) feet, being a part of Lot no. 63 of the Haynesworth and Turfman lands and being the same conveyed to me by Rhoda L. Haynesworth September 22, 1922, by deed recorded in Vol. 75 at Page 359, R.M. Co. Office for Greenville County.
