TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, George J. Moore  
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, the said George J. Moore  
in and by my certain note or obligation, bearing date the 21st day of October 1929

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Nine Hundred (\$900.00) Dollars,

with interest thereon at the rate of seven per centum per annum, payable monthly from the 21st day of October A. D. 1929, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that I

the said George J. Moore shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of November 1929, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Sixteen + 25/100 (\$14.25)

Dollars, (\$9.00) Dollars, being the regular monthly installment payable on the nine Shares of Stock and Five + 25/100 (\$5.25)

Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Sixteen + 20/100 (\$13.20) Dollars, (\$9.00)

Dollars, being the regular monthly payment on said stock and Four + 20/100 (\$4.20) Dollars, being the monthly interest on balance due); for the next twenty months the sum of Twelve + 15/100 (\$12.15) Dollars,

(\$9.00) Dollars, being the regular monthly payment on said stock and Three + 15/100 (\$3.15) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Eleven + 10/100 (\$11.10)

Dollars, (\$9.00) Dollars, being the monthly installment on said shares of stock and Two + 10/100 (\$2.10) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Ten + 05/100 (\$10.05) Dollars, (\$9.00) Dollars, being the

monthly payment on said shares of stock and One + 05/100 (\$1.05) Dollars, being the monthly interest on balance due.) Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said nine shares of stock and the certificate thereof, the amount at such time paid shares by me to be credited as a payment upon the advance or loan made me, the said

and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against me the said George J. Moore

in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I the said George J. Moore in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me

the said George J. Moore in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

*in the city of Greenville, on the east side of Eford Street, beginning at a stake on the said street, and running thence with line of Gabriel Moore property S. 41-300. 90 feet to a stake; thence in a line parallel with Eford Street N. 46-300. 50 feet to a stake; thence with said street S. 46-300. 90 feet to a stake on Eford Street; thence with said street S. 46-300. 50 feet to the beginning.*
