C. L. Jones
 of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:
 WHEREAS, *C. L. Jones*, the said *C. L. Jones*,
 in and by *my* certain note or obligation, bearing date the *29* day of *November*, 192*9*,
 indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly
 incorporated under the laws of such State), in the sum of *Forty + 87/100 (\$41.87)* Dollars,
 with interest thereon at the rate of *eight* per centum per annum payable monthly from the *29* day of *November*, A. D. 192*9*,
 according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that
 the said *C. L. Jones* shall pay or cause to be paid to the said

Twenty + 87/100 (\$21.87) Dollars, being the regular monthly payment on said stock and *Nine + 15/100 (\$9.15)* Dollars, being the monthly interest on balance due);
 for the next twenty months the sum of *Twenty + 87/100 (\$21.87)* Dollars, being the regular monthly payment on said stock and *Five + 33/100 (\$5.33)* Dollars,
 (being the monthly interest on balance due) for the next twenty months pay the sum of *Twenty + 87/100 (\$21.87)* Dollars, being the monthly installment on said shares of stock and
Five + 32/100 (\$5.32) Dollars, being the monthly interest on balance due); for the next twenty months pay the
 sum of *Twenty + 87/100 (\$21.87)* Dollars, being the monthly installment on said shares of stock and *Five + 32/100 (\$5.32)* Dollars, being the monthly interest on balance due.)
 Each of the above payments to be made on the 20th or before the last day of each month shall thereupon surrender to the Company the said *19*

 in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company,
 according to the terms and conditions of the said note or obligation, and also in consideration of the further sum of Five Dollars to the said Company,
 the said *C. L. Jones* in hand well and lawfully gave, sold, conveyed, granted, released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust
 Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and bounded as follows:

*on the road known as Mary Chase Lane, leading
 from the old plantation road to Lewis Station, both
 known as the Greenville and a part of the later
 tract no. 10, which is a part of the later
 plat recorded in the Greenville County, and bounded
 and bounded as follows: Beginning at the
 corner of lot No. 9, on the corner of Mary Chase Lane, at
 road No. 9, on the corner of Mary Chase Lane, at
 thence *32* feet to a point in said road,
 and containing *30* acres, being the same lot
 of land conveyed to me, the said *C. L. Jones*, by
