WHEREAS, *I*, the said *J. J. Prince*

in and by *my* certain promissory note in writing, of even date with these presents *am* well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of *Two hundred no/100* Dollars,

Greenville Township, known as Lot no. 22 on Plat of Highland, recorded in R. M. L. for said County in Plat Book C. Page 146, and having a frontage of seventy feet on Virginia Avenue, and running back one hundred thirty feet, being the same conveyed to me by F. J. Jester, by deed dated September, 5, 1919, recorded in Book 49, Page 170.
