Bruce** in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt thereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING AND LOAN ASSOCIATION all that piece, parcel or lot of land lying in Greenville County, South Carolina,

**In Greenville Township, about two miles West of Greenville Courthouse, near Monaghan Mills, and being known as lot No. 19 on plat of City View property, which plat is recorded in Plat Book E, page 124, and having the following metes and bounds: Beginning at an iron pin on Center Street, 50 feet from the intersection of Center Street and Y.M.C.A. Street and running thence with line of lot No. 19, N. 0-30 E. 175.6 feet to iron pin; thence with a line almost parallel with Center Street N. 85 E. 50 feet to an iron pin, corner of lot No. 20; thence with line of lot No. 20, S. 0-30 W. 172 feet to iron pin on Center Street; thence with said Center Street S. 82 W. 50 feet to the beginning corner.**
