I, *J. A. Jackson*

WHEREAS, I, the said *J. A. Jackson*

in and by *my* certain promissory note in writing, of even date with these presents *am* well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of *Eleven hundred 20/100* Dollars,

A. Jackson*

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt thereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING AND LOAN ASSOCIATION all that piece, parcel or lot of land lying in Greenville County, South Carolina, *& Greenville Township,*

*known and designated as lots nos 103, 104 and 105 on plat of Homewood recorded in P.M.C. Office for said County, having a frontage of 50 feet each and a depth of 150 feet in parallel lines, save and except a triangular strip sold off lot no. 103 to G.S. & A. Railway (now Piedmont and Northern Railway) by Adam Snyder, deed recorded in Book 11, Page 438.*
