WHEREAS, I, the said John Bates

in and by my certain promissory note in writing, of even date with these presents, am well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full and

just sum of Thirty-five Hundred and no/100 Dollars, to be paid on or before the date when the 34 Series of the Instalment Note of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if I fail to pay said interest or to comply in all respects with the By-Laws of said Association, for the space of thirty days, then said debt shall become immediately due and payable, together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the same to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hand of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or legal proceedings of any kind (all of which is secured under this mortgage), as provided in and by the said note, reference being thereunto had, will more fully appear.

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt thereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING AND LOAN ASSOCIATION all that piece, parcel or lot of land lying in Greenville County, South Carolina,

All those certain pieces or lots of land in Greenville Township, Greenville County, State of South Carolina, about two miles West of Greenville County Court House, and being known and designated as Lots Nos. 1, 2 and 9 in Block 4 of plat of City View Land Company, made by F. F. Rogers and recorded in Plat Book A, page 227, R. M. C. office for Greenville County, and having the metes and bounds, according to said plat, to which plat reference is hereby made for a more complete description.

Lot No. 1 is the same conveyed to me by J. D. Adams by deed dated August 21, 1918, and recorded in Volume 25, page 524, R. M. C. office for Greenville County.

Lot No. 2 is the same conveyed to me by F. M. Dacus, Trustee, by deed dated October 21, 1912, and recorded in Volume 12, page 491, R. M. C. Office for Greenville County.

Lot No. 9 is the same conveyed to me by J. O. Sutton and C. L. West by deed dated February 19, 1926, and recorded in Volume 104, page 105, R. M. C. office for Greenville County.
