WHEREAS, **I**, the said **Adell Wilbanks Thomason**

SEND GREETING:

in and by **my** certain promissory note in writing, of even date with these presents, well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full and just sum of **Sixteen Hundred no/100**
